RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE

1. Application

Gourav made the application on the prescribed form received on 13 February 2020. The applicant intends using the certificate at the Crown Hotel (Hotel style On Licence), which the applicant has worked in for nearly 10 months. The applicant has had a managers certificate previously but let it lapse in 2019.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

2. Decision Making

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

3.1 Police – No opposition within report dated 25 February 2020.

3.2 Licensing Inspector – Full report assessing **Gourav’s** credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate and recommends that the Certificate be approved. The inspector also notes the applicant has a current work visa which now permits him to work anywhere in NZ but expires on 2 August 2020.

4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Gourav** meets the criteria to hold a Managers Certificate under the Act.

5 Decision

Accordingly the application is **Approved** for issue for a period from the date of issue to **2 August 2020**. If the applicant/certificate holder can produce a suitable work visa to this DLC then the period of issue can be extended to a full one year to reflect the work visa, should it be obtained.
