### **RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

#### **1. Application**

**Josefa Camaibulu** made the application on the prescribed form received on the 13 July 2020. The applicant intends using the certificate at 'The Rose Irish Pub' (Tavern Style On-licence), where the applicant has worked for over 6 months. The applicant has other industry experience as well.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions. The applicant previously held a certificate but let it lapse.

#### **2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

#### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 23 July 2020.

**3.2 Licensing Inspector** – Full report assessing **Josefa Camaibulu's** credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act

to hold a managers certificate and recommends that the certificate be approved subject to the undertaking the applicant has signed in relation to work visa limitations.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Josefa Camaibulu** meets the criteria to hold a Managers Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year subject to a notation on the certificate relating to the undertaking that the certificate will only be used in conjunction with a current work visa.
