### **RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

#### **1.   Application**

**Taradale Club Incorporated** made the application on the prescribed form received on 21 October 2020. The application for redefinition of Club Licence is in relation to the clubs premises situated at 55 Wharerangi Road, Greenmeadows, Napier 4110.

The general nature of the business is that of a Club. The Taradale Club has been incorporated and operating as a Club for many years.

The redefinition is required as the Club continues to redefine its premises into an On and Club licence to reflect the diverse nature of the business. The redefinition seeks to remove an area from the Club licensed area which will allow it to be incorporated into their On Licence. This was shown on the floor plan provided.

#### **2.   Decision Making**

In considering this application for Club-Licence redefinition the licensing committee had regard to the criteria under section 105 of the Act. The Committee is of the view the redefinition meets s.105 criteria.

**3. Reporting Agencies**

The following reports were received under section 103 and 129 of the Act and taken into account during the decision.

**3.1 Police** – Report received on 30 October 2020 of no opposition.

**3.2 Medical Officer of Health** - Report received on 22 October 2020 of no opposition.

**3.2 Licensing Inspector** – Full report dated 25 November 2020. The inspector was satisfied the application met the relevant criteria and therefore supported the redefinition of the club licence to **Taradale Club Incorporated**.

**4. Conclusion**

Based on the evidence provided to me within the complete file, my assessment above of section 105 matters and the past operation of the premise/licensee, I conclude that the application meets the statutory criteria to be granted a redefinition of Club-Licence under the Act.

**5. Decision**

The redefined licence can be issued subject to the existing conditions.

The application is **Approved** for issue immediately.
