**IN THE MATTER** of an application by **Catherine Boyes** for a Manager's Certificate pursuant to section 219 of the Act.

The manager's certificate application (MC4081) had no objections filed and no matters of opposition raised under section 220 reports, therefore the matter was considered by the Napier District Licensing Commissioner in accordance with sections 221, 222 and 223 of the Act.

### **RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

#### **1. Application**

**Catherine Boyes** made the application on the prescribed form received on the 2 June 2020. The applicant intends using the certificate at '3 Doors Up' (Restaurant Style ON-licence), where the applicant has worked for over four years.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

#### **2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

#### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 12 June 2020.

**3.2 Licensing Inspector** – Full report assessing **Catherine Boyes**'s credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate and recommends that the Certificate be approved. The Inspector noted the applicants' relatively minor experience in front of house duties but reconciled this aspect with the fact the applicant did well in the interview and the premise being low risk.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Catherine Boyes** meets the criteria to hold a Managers Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year.
