**RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

**1. Application**

**Alessia Pascale** made the application on the prescribed form received on 10 May 2019. The applicant left the country not long after this time and has only since returned this year. The applicant intends using the certificate at the F G Smith Eatery (Cafe Style On-Licence), which the applicant has worked in for over one year.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

The applicant only has a Visa to 13 December 2020.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- (d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#);
- (e) any matters dealt with in any report made under [section 220](#).

### 3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 16 May 2020.

**3.2 Licensing Inspector** – Full report assessing **Alessia Pascale**'s credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a manager's certificate and recommends that the Certificate be approved.

### 4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Alessia Pascale** meets the criteria to hold a Manager's Certificate under the Act.

### 5 Decision

Accordingly the application is **Approved** for issue for a period until the applicants Work Visa expiry date i.e. 13 December 2020.

**Note:** This period of issue may be extended up until one year from certificate issue date upon receipt of suitable information showing extension of certificate holders work visa.
