**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**IN THE MATTER** of an application by **Qi Guo (Edison)** for a Manager's Certificate pursuant to section 219 of the Act.

The manager's certificate application (MC4151) had no objections filed and no matters of opposition raised under section 220 reports, therefore the matter was considered by the Napier District Licensing Commissioner in accordance with sections 221, 222 and 223 of the Act.

### **RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

#### **1. Application**

**Qi Guo (Edison)** made the application on the prescribed form received on the 7 September 2020. The applicant intends using the certificate at 'Friends Restaurant and Bar' (Restaurant style On-licence), where the applicant has worked for over 1 year.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions apart from that discussed above.

#### **2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

#### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 18 September 2020.

**3.2 Licensing Inspector** – Full report assessing **Qi Guo (Edison)**'s credentials against the Acts criteria. The inspector concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate. The inspector refers to previous issues with the applicant's knowledge of the Act and his responsibilities including a failed hearing by this Committee. However the applicant has

undertaken a further interview assessment which he has passed and therefore the Inspector now has no opposition.

The applicant has agreed to an undertaking being annotated on his certificate limiting its use to the Friends restaurant.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Qi Guo (Edison)** meets the criteria to hold a Manager's Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year subject to the undertaking.
