RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE

1. Application

Kuljit Parihar made the application on the prescribed form received on the 29 July 2020. The applicant intends using the certificate at 'The Maraenui Four Square' (Grocery Style Off-licence), where the applicant has worked for over 10 years. The applicant previously held a certificate but let it lapse.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

2. Decision Making

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

3.1 Police – No opposition within report dated 19 August 2020.

3.2 Licensing Inspector – Full report assessing **Kuljit Parihar's** credentials against the Acts criteria. The inspector concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate. The inspector rightly points out that the applicant's experience is limited to managing Grocery Style Off

Licence and therefore recommends and has received an undertaking from the applicant stating they will limit their use of the certificate to those type of licences.

4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Kuljit Parihar** meets the criteria to hold a Managers Certificate under the Act.

5 Decision

Accordingly the application is **Approved** for issue for a period of one year and a notation to be placed on the certificate relating to the undertaking.
