DECISION

1. Introduction

This is an application by **Rotary Club of Taradale** for a special licence in regard to a series of events to be held at 8 Meeanee Road, Taradale, Napier and known as Taradale Town Hall. The nature of the events for which the licence is sought are 'Rotary Meetings'.

The dates and hours sought are –

- **Every Thursday from 5.00pm to 10.30pm for the 12 month period commencing 25th March 2021 and ceasing 24th March 2022.**

2. Application

The application was received on 5 March 2021 and included a site plan showing the area to be licensed.

The application was not advertised and no opposition or notice of desire to be heard has been received under section 141 of the Act. Accordingly we deal with the matter on the papers in accordance with section 202(1).

In considering the application for special licence the committee had regard to the following criteria under section 142 of the Act:

- (a) the object of this Act:
- (b) the nature of the particular event for which the licence is sought and, in particular,—
 - (i) whether the applicant is engaged in, or proposes at the event to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods; and
 - (ii) whether the applicant is engaged in, or proposes at the event to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:
- (c) the suitability of the applicant:

- (d) any relevant local alcohol policy:
- (e) whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of the licence:
- (f) the days on which and the hours during which the applicant proposes to sell alcohol:
- (g) the design and layout of the premises concerned:
- (h) whether the applicant has appropriate systems, staff and training to comply with the law:
- (i) any areas of the premises that the applicant proposes should be designated as restricted areas or supervised areas:
- (j) any steps the applicant proposes to take to ensure that the requirements of this Act in relation to the sale and supply of alcohol to prohibited persons are observed:
- (k) the applicant's proposals relating to—
 - (i) the sale and supply of non-alcoholic drinks and food; and
 - (ii) the sale and supply of low-alcohol drinks; and
 - (iii) the provision of help with or information about alternative forms of transport from the premises:
- (l) any matters dealt with in any report from the Police, the Medical Officer of Health, or an inspector made under [section 141](#).

3. Reporting Agencies

The following reports were received under section 141 of the Act.

Police Report – No opposition within report received on 24 March 2021.

Medical Officer of Health – No opposition within report received on 10 March 2021.

Licensing Inspector Report – Full report provided by the inspector including assessment of application against section 142 criteria. The Inspector concludes that the application is complete and will likely meet the criteria of the Act. Draft conditions are also offered by the inspector.

The file, including inspectors report, included the following key matters –

- The applicant is an Incorporated Society who have operated a special licence for these club events for many years. The Rotary Club has held many special events previously with no known issues of late. The licence is for the Club's Thursday night meeting held on 52 consecutive weeks of the year.
- Suitability is not challenged.
- The premise is a town hall that has been in existence for a number of years, is zoned for such events and a continued special licence should not reduce amenity and good order of the locality. The premise has held these special licensed events previously.
- The premise is suitable for the type of event and layout has been suitable in the past. The marked floor plan was included which shows the whole town hall area including the Rotary room off one end. No designation is requested.
- The hours appear relevant for the events being undertaken.
- A non-certified manager is nominated for the event which is endorsed with a s.213(2) waiver.
- Both the Police and MOH have no opposition to the application.

4. Decision

The Committee is satisfied as to the matters under the Act to allow the application to be granted. The application for Special Licence is **Approved** for issue subject to the conditions outlined in the inspectors report.
