IN THE MATTER of an application by **Kalyarut MacDonald**
for a Managers Certificate pursuant to section
219 of the Act.

The managers' certificate application (MC4248) had no objections filed and no matters of opposition raised under section 220 reports, therefore the matter was considered by the Napier District Licensing Commissioner in accordance with sections 221, 222 and 223 of the Act.

RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE

1. Application

Kalyarut MacDonald made the application on the prescribed form received on the 19 February 2021. The applicant intends using the certificate at 'Aroy Thai Restaurant' (Restaurant Style On-licence - pending), where the applicant has worked for over four months.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions apart from that discussed above.

2. Decision Making

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

3.1 Police – No opposition within report dated 22 February 2021.

3.2 Licensing Inspector – Full report assessing **Kalyarut MacDonald's** credentials against the Acts criteria.

The Inspector notes the applicant has limited industry experience and has actually not worked within a premises with a current liquor licence. The Inspector gives a detailed account however why he thinks the applicants knowledge is sufficient enough for her to be granted a certificate.

Additionally the applicant has signed an undertaking limiting the certificate use to the restaurant. Given the restaurant is a low risk premise and the applicants excellent knowledge of the Act, the inspector concludes that the application is complete, in all other aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate.

4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Kalyarut MacDonald** meets the criteria to hold a Managers Certificate under the Act.

5 Decision

Accordingly the application is **Approved** for issue for a period of one year and the undertaking annotated on the certificate.
