The manager's certificate application (MC4434) had no objections filed and no matters of opposition raised under section 220 reports, therefore the matter was considered by the Napier District Licensing Commissioner in accordance with sections 221, 222 and 223 of the Act.

**RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

**1. Application**

**Jessica Te Moananui** made the application on the prescribed form received on the 28 April 2022. The applicant intends using the certificate with the 'Countdown Napier' (Supermarket Style Off-licence). The applicant has over nineteen months experience in the industry.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

**3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 9 May 2022.

**3.2 Licensing Inspector** – Full report assessing **Jessica Te Moananui**'s credentials against the Acts criteria.

The Inspector notes the applicant has exclusive experience in off style premises and has signed an undertaking that the certificate would only be used in this style of premises.

The inspector concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a manager's certificate.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Jessica Te Moananui** meets the criteria to hold a Manager's Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year and the undertaking being annotated to the certificate.
