**DECISION**

**1. Introduction**

This is an application by **Napier Repertory Players Incorporated** for a special licence in regard to theatre events to be held at 76 McGrath Street, Napier and known as 'Little Theatre'. The nature of the events for which the licence is sought are 'Live Theatre Performances'.

**The dates and hours sought are –**

- Monday 14 November 2022, between 7.00pm & 11.00pm
- Wednesday 16 November 2022, between 7.00pm & 11.00pm
- Thursday 17 November 2022, between 7.00pm & 11.00pm
- Friday 18 November 2022, between 7.00pm & 11.00pm
- Saturday 19 November 2022, between 7.00pm & 11.00pm
- Sunday 20 November 2022, between 4.00pm & 8.00pm
- Wednesday 23 November 2022, between 7.00pm & 11.00pm
- Thursday 24 November 2022, between 7.00pm & 11.00pm
- Friday 25 November 2022, between 7.00pm & 11.00pm
- Saturday 26 November 2022, between 7.00pm & 11.00pm

## 2. Application

The application was received on 14 September 2022 and included a site plan showing the area to be licensed.

The application was not advertised and no opposition or notice of desire to be heard has been received under section 141 of the Act. Accordingly we deal with the matter on the papers in accordance with section 202(1).

In considering the application for special licence the committee had regard to the following criteria under section 142 of the Act:

- (a) the object of this Act:
- (b) the nature of the particular event for which the licence is sought and, in particular,—
  - (i) whether the applicant is engaged in, or proposes at the event to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods; and
  - (ii) whether the applicant is engaged in, or proposes at the event to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:
- (c) the suitability of the applicant:
- (d) any relevant local alcohol policy:
- (e) whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of the licence:
- (f) the days on which and the hours during which the applicant proposes to sell alcohol:
- (g) the design and layout of the premises concerned:
- (h) whether the applicant has appropriate systems, staff and training to comply with the law:
  - (i) any areas of the premises that the applicant proposes should be designated as restricted areas or supervised areas:
  - (j) any steps the applicant proposes to take to ensure that the requirements of this Act in relation to the sale and supply of alcohol to prohibited persons are observed:
- (k) the applicant's proposals relating to—
  - (i) the sale and supply of non-alcoholic drinks and food; and
  - (ii) the sale and supply of low-alcohol drinks; and
  - (iii) the provision of help with or information about alternative forms of transport from the premises:
- (l) any matters dealt with in any report from the Police, the Medical Officer of Health, or an inspector made under [section 141](#).

## 3. Reporting Agencies

The following reports were received under section 141 of the Act.

**Police Report** – No opposition within report received on 16 September 2022.

**Medical Officer of Health** – No opposition within report received on 20 September 2022.

**Licensing Inspector Report** – Full report provided by the inspector including assessment of application against section 142 criteria. The Inspector concludes that the application is complete and will likely meet the criteria of the Act. Draft conditions are also offered by the inspector.

The file, including inspectors report, included the following key matters –

- The applicant is an Incorporated Society first registered in 1935 who have operated a special licence events on this premise for many years. The Club has held many special events previously with no known issues of late.
- Suitability is not challenged.
- The premise is a theatre that has been in existence for a number of years, is zoned for such events and a continued special licence should not reduce amenity and good order of the locality. The premise has held these special licensed events previously.
- The premise is suitable for the type of event and layout has been suitable in the past. The marked floor plan was included which shows the auditorium and foyer will be licensed. No designation is requested.
- The hours appear relevant for the events being undertaken.
- One certified manager is nominated for the events. This is supported by the inspector.
- Both the Police and MOH have no opposition to the application.

#### 4. Decision

The Committee is satisfied as to the matters under the Act to allow the application to be granted. The application for Special Licence is **Approved** for issue subject to the conditions outlined in the inspectors report.
