The manager's certificate application (MC4497) had no objections filed and no matters of opposition raised under section 220 reports, therefore the matter was considered by the Napier District Licensing Commissioner in accordance with sections 221, 222 and 223 of the Act.

**RESERVED DECISION OF THE NAPIER DISTRICT LICENSING COMMITTEE**

**1. Application**

**Prince Kumar** made the application on the prescribed form received on the 20 August 2022. The applicant intends using the certificate at the 'Thirsty Liquor Taradale' (Bottle Store Style Off-licence). The applicant has over a years' experience at this licensed premise and previously has held a certificate before allowing it to lapse.

The application included evidence of obtaining the necessary License Controller Qualification and attesting to their experience and skills. The applicant declared they have no convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- (a) *the applicant's suitability to be a manager:*
- (b) *any convictions recorded against the applicant:*
- (c) *any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- (d) *any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- (e) *any matters dealt with in any report made under [section 220](#).*

**3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report received 8 September 2022.

**3.2 Licensing Inspector** – Full report assessing **Prince Kumar**'s credentials against the Acts criteria.

The Inspector notes the previous certificate held an undertaking limiting its use to 'off' type licences. It's recommended this continues.

The inspector concludes that the application is complete, in all aspects appears to meet the criteria of section 222 of the Act to hold a managers certificate.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Prince Kumar** meets the criteria to hold a Managers Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year.
