

## Chapter 30 WASTEWATER TREATMENT ZONE - RULES

### INTRODUCTION

This chapter contains rules managing land uses in the Wastewater Treatment Zone. The Wastewater Treatment Zone identifies an area of land associated with the treatment of the City's wastewater at Awatoto. It provides for the specific activities that are required for the treatment of the City's wastewater. It also provides for those land uses that have significant effects on the City's infrastructure in a location where those effects can be managed to minimise any adverse effect on the environment. Wastewater treatment processes are often perceived to have unpleasant effects on amenity values, particularly in relation to the generation of odours. However, with current technology and management practices, these effects can be minor in nature. In many respects the levels of effects to arise from wastewater treatment are likely to be considerably lower than those of traditional industrial zones.

All rules apply throughout the zone unless otherwise stated.

### 30.1 Summary of Wastewater Treatment Zone Rules

The following is a quick reference guide that summarises the Wastewater Treatment Zone Activity Table. It is intended as a guide only and must not be used in place of the Wastewater Treatment Zone Activity Table and Condition table elsewhere in this Chapter.

<p><b>30.20 Light Spill</b></p> <p>1.
