# Street Stalls, Traders Markets, Stall and Mobile Shop Signage Policy

## Policy

### Street Stalls – Emerson Street

- 1. Any future leasing of the designated stall sites in Emerson Street be prohibited.
- 2. The current ownership and management rights of the present leases are not transferable.
- 3. The portion of Emerson Street between Clive Square and Memorial Square be approved as a designated stall site, for the purposes of the Farmers Market (ie, a market organised by the Hawke's Bay Food Group or any subsequent or similar organisations).
- 4. The existing stall holders to be informed that their tenure will run for a maximum term of 12 months after their existing lease expires.

That a "No Stalls" policy for the Emerson Street area be adopted from 5 February 2009, or once Mr Blank's stall (Lil Orbit Donuts) occupancy ceases, whichever comes first.

### Street Traders

- 1. That no leasing of Marine Parade reserve to Gypsy Fairs/Tinker Markets be allowed during Christmas to Easter, with the exception of the two weekly markets and the annual New Year Mardi Gras.
- 2. That no trading or hawkers licences be issued for the CBD/Marine Parade area during Christmas through to Easter, other than to traders or hawkers whose business complements other city events in the opinion of the authorising officer after consultation with other activity organisers for such periods to be determined by the authorising officer.

#### **Markets in Napier**

- 1. That regular weekend and one day markets be allowed in commercial zones and on the Marine Parade.
- 2. That schools, churches, recreational and charity groups be allowed to run one-off markets and annual fairs on their own premises without restrictions.
- 3. That the Bay City Bazaar be treated as an existing use and allowed a site near the old Kiwi House on the Marine Parade for their markets.
- 4. That an application to set up a market beyond February 2002 at Anderson Park, be subject to the applicant obtaining planning consent and a licence to occupy.
- 5. That the application to set up a weekend market on the Marine Parade carpark, between the skating rink and Marineland, be approved subject to the applicant entering into an agreement with the Napier City Council.
- 6. That the Maraenui market continue as it is.
- 7. That the setting up of a 'Farmers Market' in Napier be facilitated.

- 8. That no restriction be placed on the number, size or location of regular markets in Napier, provided that the markets are on commercial sites, and designated areas on Anderson Park and Marine Parade reserve.
- 9. That no markets be allowed in Memorial Square.
- 10. That this policy be reviewed in November 2002.

That the Napier Development Association operates their market only on Saturday morning on the site north of the Ocean Spa complex.

### Stall and Mobile Shop Signage

- 1. That operators of stalls and mobile shops be required by condition of their licence to display no more than two advertising signs.
- 2. That the signs displayed by the operators be required by condition of their licence to have a maximum aggregate size of two square meters.

#### **Policy Review**

The review timeframe of this policy will be no longer than every five years.
